MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objective and Strategies

The primary objective of the Sustainable Income 20/80 Fund (the “Fund”) is the achievement of income generation with some level of capital preservation and long-term capital appreciation by investing in a mix of global equity and fixed income securities, mutual funds and/or exchange traded funds (ETFs) while also meeting a set of environment, social and governance (ESG) standards and investment criteria.

The Fund aims to achieve its investment objective primarily through the investment in Guardian mutual funds and ETFs and/or third-party mutual funds and ETFs that provide exposure to a diversified set of asset classes, including global equities, fixed income securities and real assets. Investments are primarily selected on the basis of their ability to provide the Fund with compelling long-term risk-adjusted returns and to meet a minimum set of ESG investment standards.

Risk

The risks associated with investing in the Fund remain as discussed in the prospectus. The Fund may be suitable for investors with a low tolerance for risk, particularly those who are looking for a fund that invests in a mix of fixed income securities and global equity with investments that meet a set of ESG investment standards and criteria, and who have a short to medium term investment horizon.

Results of Operations

This commentary is based on the performance of Series A units of the Fund. Returns for other Series of units may vary, largely due to differences in fees and expenses. Please refer to the Past Performance section for specific Series level performance details. Please note that this Fund invests primarily in other Guardian mutual funds and ETFs, and/or other third-party mutual funds and ETFs [the “Underlying Funds”]. Individual securities referenced in this commentary

may refer to the securities held in one of the Underlying Funds, and not necessarily as a direct holding of this Fund.

The Fund’s net asset value did not change from \$1.7 million as at December 31, 2024 to June 30, 2025, as there were minimal subscriptions and investment performance, net of fees and expenses.

Series A units of the Fund posted a return of 1.7% for the period. The Fund’s blended benchmark, 5% S&P/TSX Composite Index, 15% MSCI World Index(Net, C\$) and 80% FTSE Canada Universe Bond Index. returned 2.3% for the same period. The Series A return is after the deduction of fees and expenses, unlike the benchmark’s return.

Global financial markets experienced significant volatility over the first six months of 2025, as the elevated uncertainty surrounding the approach to US economic policy by the new Administration led to a material downgrade of the outlook for economic growth worldwide while also boosting inflation expectations which created added difficulties in assessing the potential path for monetary policy. Receding fears of the “worst case scenario” materializing as the White House backed off its more aggressive threats and persistent resilience in the economic dataflow, however, resulted in a marginal improvement in forecasts and supported a rebound in risk assets through the end of the period. Overall, global equities turned in moderate positive returns over the six months ended June 2025, that were predominantly concentrated outside of the US. Bond market performance was modestly positive as well for the period as policy rate cuts put downward pressure on short and mid-term rates, with shorter duration and corporate bonds outperforming those securities with longer-term to maturities and issued by governments.

The Fund’s tactical underweight to Fixed Income resulted in positive contributions to performance from asset allocation over the first six months of 2025. The bias toward credit in the Fund’s Fixed Income allocations also proved accretive, particularly the position in the iShares ESG Advanced Canadian Corporate Bond Index ETF.

These effects, however, were partially offset by the negative impact of security selection within Global Equity allocations that detracted from relative performance versus the Fund's blended benchmark. In particular, there was material underperformance by some concentrated Global Equity exposures (namely the Guardian Fundamental Global Equity Fund, Guardian i³ Global Dividend Growth Fund, Guardian Directed Premium Yield Portfolio, and the Guardian U.S. Equity All Cap Growth Fund) as the market rally at the end of the period was driven more by valuation expansion than earnings growth, favoring high-beta, mega-cap tech stocks and disadvantaging more conservatively positioned strategies focused on downside protection. The material underperformance of the iShares ESG Advanced Total USD Bond Market ETF versus the domestic bond benchmark also weighed on relative performance.

While the Manager was cognizant of the risks posed by heightened uncertainty over the first six months, they remained comfortable with exposures and the decision was made to not make any material changes to the overall allocations to asset classes. That said, the Manager made allocations to specific thematic investments in Q1, namely investment strategies that focused on utilities (iShares Global Utilities ETF), infrastructure (BMO Global Infrastructure Index ETF) and water management (iShares MSCI Water Management Multisector ETF), as well as adding exposure to a green-bond specific strategy (WealthSimple North American Green Bond ETF) at the expense of trimming other portfolio positions within asset class sleeves.

The Fund retained its Morningstar ESG Risk Rating of "Above Average" throughout the period, placing the Fund in the top third of its global category peers from an ESG risk score perspective.

The Manager will seek to include in the Fund's portfolio Underlying Funds that have a minimum sustainability rating at the time of purchase, and whose manager is a signatory to the UN PRI. On an ongoing basis the Fund seeks to maintain a sustainability rating of at least above-average, on a weighted average basis. As this Fund is a fund-of-funds, it does not directly

engage in proxy voting or active engagement, rather it is required to achieve minimum ESG standards and investment criteria, which the Manager seeks to achieve both at the time of investment in an Underlying Fund and on an ongoing basis. Where the Underlying Fund is a related issuer, this is conducted by Guardian Capital LP as the Manager of those Underlying Funds. In the case of third-party underlying funds, there may be no direct engagement by Guardian Capital LP with the issuers held in those funds. Please read the underlying third party fund's prospectus for a more detailed explanation on their Responsible Investing and/or Proxy Voting Policies.

Recent Developments

Economic uncertainty remains unfathomably high due to the persistent lack of clarity on the direction of US trade policy, but the potential for a "scorched earth" approach that was tabled three months ago on "Liberation Day", and the subsequent escalation of tensions with China that put tariff rates to levels not seen since the turn of the 1900s, now looks to be off the table and efforts are being made toward establishing agreements with lower barriers.

General tariff rates appear likely to remain higher than at any point in the post-World War II era and stand to restrain economic activity, while also putting upward pressure on prices. The estimated 10% to 15% average levy on goods imported into the US, however, is considerably less painful for businesses and consumers than the rates north of 30% proposed three months ago and likely means less of a ripple effect across the global economy. It remains the case that underlying activity has continued to be firmer than was

anticipated against the numerous headwinds seen this year.

Accordingly, consensus expectations for growth, which were on a one-way ticket lower since the start of the year — and inflation expectations, which have been moving sharply higher — have both begun moving in more favourable directions. Relative to the start of the year, global growth is still expected to be notably slower and inflation higher, but the outlook for both are “less bad”.

The prospect of less potential inflation pressure eases the burden on global central banks tasked with the stewardship of their respective currencies, with markets again beginning to price in the prospect of further, albeit modest, easing by the end of the year and taking market rates down from recent highs.

The combination of “less bad” expectations for growth, inflation and interest rates has translated into analysts making fewer downward (and more upward) revisions to earnings forecasts which have factored into global equity markets staging a near 20% rebound from their April lows.

The question of where things go from here clearly depends on whether the downside risks to the outlook continue to subside — and that is clearly a big “if” as trade policy will soon return to the forefront with the 90-day tariff delays lapsing in the coming weeks, the geopolitical backdrop remains fraught, concerns are rising over fiscal sustainability as government table budgets that show little restraint, while the impact of tariffs and related uncertainty will become more prevalent in the dataflow.

Markets, however, are aware of the many hazards on the road ahead and have shown a willingness to continue to climb the “Wall of Worry”. That there is also potential for the outlook to not only turn “less bad” but possibly actually “good” — for example, if the trade deals are reached that reduce tariffs to a greater degree, geopolitical tensions cool, focus in the U.S. turns to market-friendly developments such as deregulation and/or added progress with respect to developments in artificial intelligence — that in turn

could give risk assets an added boost through the remainder of the year.

For bonds, the expectation of steepening curve against the prospect of rate cuts later in the year and range-bound longer-term interest rates means there is little desire to add duration. High quality mid-term corporate credit continues to offer attractive all-in yields and provide for a favour risk/reward profile.

With respect to the Fund’s thematic allocations, the outlook for global utilities remains promising as grid resilience is becoming an increasingly important focus, given the number of extreme weather events and related pressure on electricity grids taking place globally and particularly in the US. The outlook for water management also remains solid given the significant water usage demands of data centers and the strong data center build out trajectory to keep up with AI demand.

The Fund’s portfolio asset mix remains overweight Equity, with a bias toward global “quality growth” strategies. Fixed Income allocations are skewed toward high quality corporate credit with below benchmark duration. The Manager will continue to monitor economic and market developments closely and stands ready to tactically exploit opportunities that may present themselves.

The regime change in the US and the accompanying uncertainty about the Administration’s approach to economic policy, especially with respect to international relations and trade, has clouded the outlook for not just the US but the entire world and resulted in significant financial market volatility. The introduction of sweeping new tariffs stands to have a significant negative impact on the trajectory of global growth, given that the export of goods and services across borders accounts for roughly one-third of global output. As well, the cost increases associated with tariffs carry material implications for global central bank policy and interest rates, adding to the uncertainty and greatly impacting investment and spending decisions, which in turn has had significant impacts on the outlook for the global economy and financial markets.

Related Party Transactions

Guardian Capital LP, the Manager of the Fund, is considered to be a “related party” of the Fund. The Manager is responsible for the day-to-day operations of the Fund and also acts as the portfolio manager, managing the investment portfolio of the Fund. These services are in the normal course of operations and the Fund pays a management fee to the Manager for these services, based on the average Net Asset Value of the Fund, as detailed in the Management Fees section below. The Manager is a wholly-owned subsidiary of Guardian Capital Group Limited, a publicly traded firm listed on the Toronto Stock Exchange.

The Manager also receives an Administration Fee from the Fund, amounting to 0.04% of the average daily net asset value of the Fund, in return for the payment by the Manager of all the variable operating expenses of the Fund. The Independent Review Committee (“IRC”) has approved the Manager’s Policy for this item and the Manager relies on this approval as a standing instruction from the IRC. The Manager received the Administration Fee and paid Fund expenses in accordance with this Policy during the period.

The Fund invests in assets in other Guardian Capital Funds, which are related issuers, and may also invest in other third-party funds which are not related (the “Underlying Funds”). With respect to investments in related issuers, the Manager has relied on the approval that it has received from the Independent Review Committee (“IRC”). The approval requires the Manager to comply with its current policy and procedures regarding investments in related issuers and to report periodically to the IRC. The Manager will not duplicate management fees paid to an Underlying Fund that is a related issuer and will not pay any performance fee in respect of any investment in the Guardian Strategic Income Fund.

Management Fees

No management fees are payable or collected for Series I units of the Fund. Series A, Series F, Series CCA and Series CCF units are subject to management fees which are based on a percentage of the average

Series NAV during each month, calculated and accrued daily, and payable monthly. The Series A and Series CCA management fee is 1.30% per annum. The Series F and Series CCF management fee is 0.50% per annum. The table below provides a breakdown of services received in consideration of the management fees, as a percentage of the management fees, for the period.

In the event that the Fund invests in another investment fund to obtain exposure to the constituent securities, the Fund may pay the management fee on the portion of the Fund’s assets invested in the other fund, as long as this would not duplicate fees for the same service and the other fund is not a related issuer.

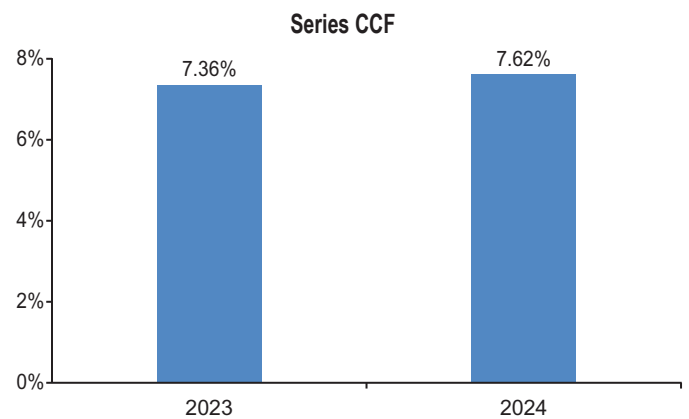
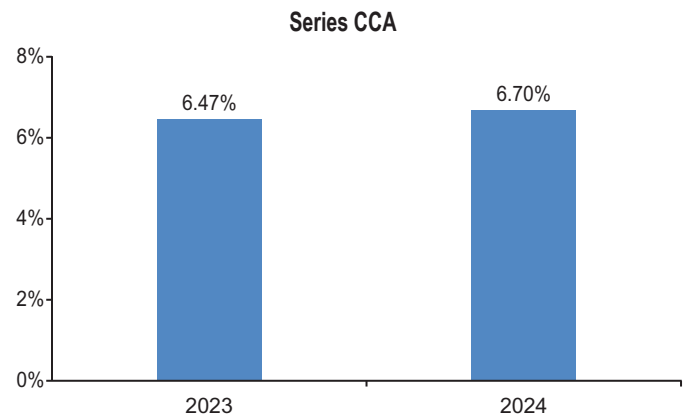
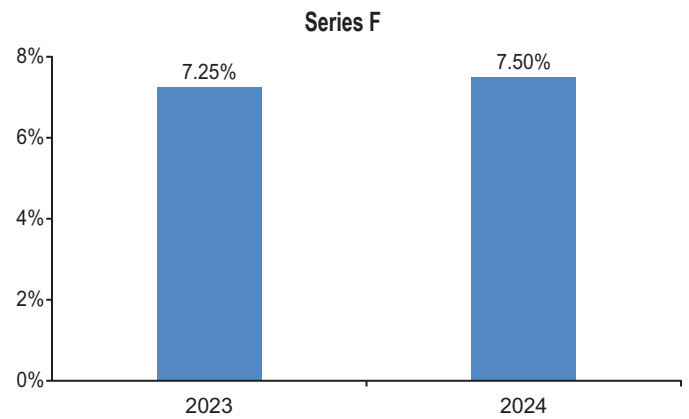
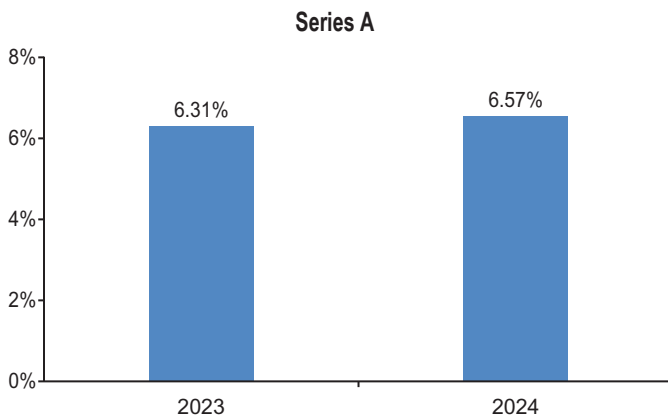
Past Performance
