WHAT DOES THE FUND INVEST IN?

The primary objective of the Fund is to provide exposure, directly or indirectly, to a diversified portfolio consisting primarily of Canadian-dollar denominated investment grade bonds, segmented into three groupings with maturities from one to three years that will provide regular income.

HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a Fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

This Fund may be suitable for you if:	In general, you will have to pay tax on any money you make on a Fund including your share of the Fund's earnings and on taxable capital gains from redeeming your investment. How much tax you pay depends on your tax rate, whether or not you hold the Fund in a registered plan and the type of earnings of the Fund (e.g. interest, dividends, capital gains, etc.). In general, you do not pay tax on your investments held in a Registered Retirement Savings Plan, Tax-Free Savings Account or other registered plan.

HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series I Mutual Fund Units of the Fund.

The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

No sales charges apply when you purchase Series I Mutual Fund Units.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

The Fund's expenses are made up of the administration fee, operating expenses and trading costs. The Series I Mutual Fund Units' annual administration fee is 0.05% of the series' value. No management fee is payable by the investor or the Fund in respect of the Series I Mutual Fund Units. Instead, an investment advisory fee is negotiated and paid directly by each Series I Mutual Fund Unit investor.

As the Fund is new, operating expenses and trading costs are not yet available.

More about the trailing commission

No trailing commission is paid in respect of this series.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch Series I Mutual Fund Units of the Fund.

Fee	What you pay
Investment Advisory Fee	Investors pay a negotiated investment advisory fee directly to us or our affiliates. The maximum percentage that may be charged for this fee is generally equal to the Series A Mutual Fund Unit management fee, which is 0.70%.
Switch Fee	0-2% of the value of Series I Mutual Fund Units you switch. This fee is charged by your representative's firm.
Short-Term Trading Fee	2% of the current value of the Series I Mutual Fund Units may be charged by us if you redeem or switch them within 45 days of purchase.
