# WHAT DOES THE FUND INVEST IN?

The primary objective of the Fund is to provide income over a pre-determined time horizon by investing in a portfolio consisting primarily of Canadian-dollar denominated investment grade bonds with an effective maturity in 2027. The Fund's termination date is anticipated to be on or about November 30, 2027.

## **HOW RISKY IS IT?**

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a Fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### **RISK RATING**

Guardian Capital LP has rated the volatility of this Fund as **low**.

# **HOW MUCH DOES IT COST?**

The following tables show the fees and expenses you could pay to buy, own and sell Series A Mutual Fund Units of the Fund.

The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

# 1. Sales charges

You have to choose the initial sales charge option when you buy Series A Mutual Fund Units. Ask about the pros and cons of this option.

### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

The Fund's expenses are made up of the management fee, administration fee, operating expenses and trading costs. The Series A Mutual Fund Units' annual management fee is 0.70% of the series' value and the annual administration fee is 0.05% of the series' value.

As the Fund is new, operating expenses and trading costs are not yet available.

## More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you hold the Series A Mutual Fund Units of the Fund. It is for the services and advice that your representative and their firm provide to you.

The trailing commission is paid to your representative's firm by the Manager, out of the management fee and is based on the value of your investment.
