The primary objective of the Fund is the provision of a balanced portfolio emphasizing income generation with some level of capital preservation and long-term capital appreciation by investing in a mix of global equity and fixed income securities, mutual funds and/or exchange-traded funds while also meeting a set of environmental, social and governance standards and investment criteria.

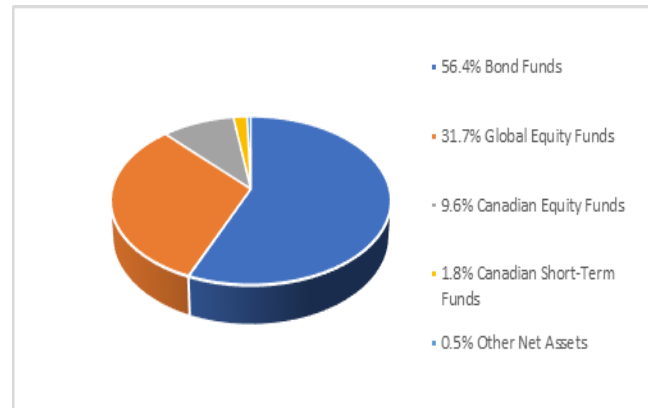
The charts below give a snapshot of the Fund's investments on February 29, 2024. The Fund's investments will change.

#### HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a Fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### RISK RATING

Guardian Capital LP has rated the volatility of this Fund as low to medium.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

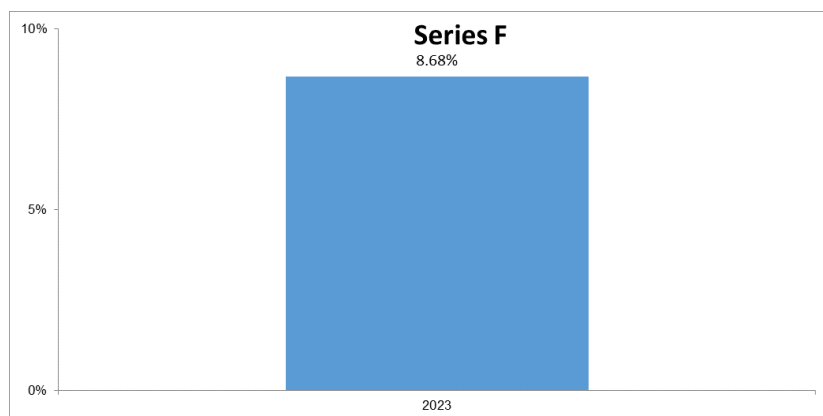

## HOW HAS THE FUND PERFORMED?

This section tells you how the Series F Units of the Fund have performed over the past calendar year. Returns are after Fund expenses have been deducted. These expenses reduce the series returns.

### Year-by-year returns

This chart shows how Series F Units of the Fund have performed in the past calendar year. The series rose in value in the past calendar year. The range of returns and change from year to year can help you assess how risky the series has been in the past. It does not tell you how the series will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for this series of the Fund in a 3-month period over the past calendar year. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average return

A person who invested \$1,000 in this series since inception now has \$1,003.39. This works out to an annual compound return of 0.16%.

## WHO IS THIS FUND FOR?

### This Fund may be suitable for you if:

- You are seeking income generation with some level of capital preservation and long-term capital appreciation from your investment.
- You are looking for a balanced fund for your portfolio with investments that meet a set of environmental, social and governance investment standards and criteria.
- You are comfortable with low to medium investment risk.
- You plan to hold this investment for the medium term.

## A WORD ABOUT TAX

In general, you'll have to pay tax on any money you make on a fund including your share of the fund's earnings and on taxable capital gains from redeeming your investment. How much tax you pay depends on your tax rate, whether or not you hold the fund in a registered plan and the type of earnings of the fund (e.g. interest, dividends, capital gains, etc.). In general, you do not pay tax on your investments held in a Registered Retirement Savings Plan, Tax-Free Savings Account or other registered plan.

If you hold your investment outside of a registered plan, you will receive a tax slip showing your share of the fund's earnings. You must include the amounts shown in your taxable income whether you get them in cash or have them reinvested. You must calculate your taxable capital gains from redemption.

## HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series F Units of the Fund.

The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

No sales charges apply when you purchase Series F Units.

### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

As at December 31, 2023, the Series F expenses of the Fund were 0.81% of its value. This equals \$8.10 for every \$1,000 invested.
